1. General Information

- 1.1 Protecting your personal data is important to us. Via this Notice we like to inform you about collecting and use of personal data in the event you visit our website.
- 1.2 Responsible party in line with art. 4 para. 7 EU General Data Protection Regulation (GDPR) is:

- 1.3 For the purpose of processing technically necessary personal data, in connection with a contract or upon your consent, cookies shall be stored on your computer if you use our website. Cookies are small text files, which are stored on your hard disc and which are connected to the browser you use; via such text file the owner of the cookie shall receive certain information. Cookies cannot execute programs or transfer viruses to your computer.
 - Irrespective of your consent you can configure your browser settings according to your purposes and e.g., reject the acceptance of certain or all cookies (see also clause 1.5). We have to point out, that you may not be able to use all functions of our website, if you reject technically necessary cookies in your browser settings.

1.4 Cookies are deleted after a certain period of time, which may vary depending on type and function of the cookie. Collected personal data shall be deleted within the legally given period of time, which depends on the purpose of use of such personal data.

1.5 Cookie Consent Manager

- a. When you visit our website, a cookie is set to record your consent to the various services. It records whether you give your consent and if so, what consent you give. You can change this selection at any time by saving your new selection in the Cookie Consent Manager.
 - If you do not activate a service in the Cookie Consent Manager but click on this service during your visit to the website, this click will be **recorded as consent** in the Cookie Consent Manager.
- b. The following data is logged in the cookie:
 - IP address
 - Consent selection
 - Date and time of selection
- c. If you delete all cookies, you will be asked for your consent again on your next visit. If you do not delete the cookie history, you will be asked after 6 months whether your consent selection is still up to date.
- d. **Legal basis:** Your consent, according to art. 6 para. 1 p. 1 lit. a GDPR.

2. Your Rights

- 2.1 You have these rights with regard to your personal data:
 - Right of access (art. 15 GDPR),
 - Right to rectification (art. 16 GDPR),
 - Right to erasure (art. 17 GDPR),
 - Right to restriction (art. 18 GDPR)
 - Right to data portability (art. 20 GDPR),
 - Right to object (art. 21 GDPR).
- 2.2 If you have given **consent** to processing your personal data, you can revoke your consent at any time in full or partially. Such revocation does only influence the validity of data processing as of the time you have made your revocation. You can administer your consent by contacting our data protection officer (clause 1.2).
- 2.3 If we base processing of your personal data on our legitimate interest, you can object. Please inform us about your reasons why we should not process your personal data. Upon your reasoning we shall evaluate the facts and either we stop or adjust the data processing, or we will demonstrate legitimate grounds for the processing.

3. Collection of Personal Data during your visit at our website

3.1 Visit at our website

Upon your visit to our website, we collect such personal data which is technically necessary to visualize our website in appealing format and quality and to secure stability and security of our website.

This data shall be recorded in a server log file:

- Landing page
- Time of first visit to website
- Volume of sent data in byte
- Website from which you referred to us
- used browser
- used operation system
- your IP-address (if so: in anonymized form)
- language and release no of your operation system

legal basis: legitimate interest to necessary functionality of our website, art. 6 para. 1 l. 1 lit. f GDPR.

3.2 Communication and Orders

If you contact us via **email** or via **phone** the personal data you provide to us (your email address, if given: your name and phone number) will be stored by us to answer your questions and to execute our business relation.

If you send an order (by email, fax or post) to us, we will store the data necessary for the execution of the order. Typically, name, postal address, email/telephone contact data are recorded. These data are used for the execution of the business relationship. They may also be used to check creditworthiness.

Legal basis: processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract, art. 6 para. 1 l. 1 lit. b GDPR. The processing of data to check creditworthiness is in our legitimate interest pursuant to Art. 6 (1) sentence 1 lit. f GDPR.

This data is being erased when it is not necessary anymore, after 10 years at the latest.

The service provider processes the following personal data to fulfil your order:

- When loading the files required to use the Eye-Able assistance software, the Eye-Able 'Simple Language' plug-in and Eye-Able Translate, a connection to the service provider's server infrastructure must be established. This generates all the data of an HTTPS request, e.g. the user's IP address, the browser used or the website visited. The IP address is only available to the service provider in anonymised form.
- The text stored on the website is sent to the contractor's API for translation. The translation and the original are saved in order to avoid a new translation (caching) and to enable post-processing.

Only your e-mail address is required for receiving the newsletter.

If you do not confirm your subscription within 7 days, your information will be blocked and automatically deleted after one month.

- a. To prove the time and scope of the subscription to the newsletter (as well as the unsubscription), we store the following data by setting a cookie:
 - Timestamp of the registration or unsubscription (date and time).

7. Server

- 7.1 The hosting services underlying this website are provided by **IONOS SE** (address: Eigendorfer Straße 57, 56410 Montabauer, Germany). IONOS SE offers the services as Software-as-a-Service (SaaS) and collects and stores server log files with information that your browser transmits to us. This information includes:
 - Website visited
 - Time at the time of access
 - Amount of data sent in bytes
 - Browser used
 - Operating system used
 - IP address used (in anonymised form))
 - Language and version of the browser software
- 7.2 IONOS SE cannot relate this data to specific persons. This data will not be merged with other data sources. After a statistical evaluation, the data will be deleted, at the latest after seven (7) days. Further information can be found in the data protection regulations of IONOS SE.
